### California Child Care CPR, First Aid & Preventative Health Registration Form

All child care providers, licensed or exempt from licensing, will benefit from attending a Child Care Health and Safety Course. However, there are child care providers in California who must take the course and re-certify regularly in order to meet State Licensing requirements. Child Care Provider training consists of 16 hours of training for first-time licensees. The hours of training must be completed as follows:

- 4 hours of pediatric first aid
- 4 hours of pediatric CPR (including infant, child, and adult CPR and infant, child, and adult AED training)
- 8 hours of Preventive Health and Safety Training; this training is a one-time-only course

Every two (2) years, child care providers must renew their training by completing 4 hours of pediatric first aid and 4 hours of pediatric CPR including adult CPR and infant, child, and adult AED training.

If an instructor provides a course in fewer hours than required, the training is not in compliance with the law. Report this situation to the EMS Authority at (916) 322-4336, extension 434.

#### **Small (licensed for 6 -8) and Large (licensed for 12-14) Family Child Care Homes**

#### **Child Care Center (Licensed)**

At least one director or teacher	Pediatric CPR      Pediatric First Aid Preventative Health and Safety
If licensee is absent: at least one staff member with current training in pediatric first aid and pediatric CPR is onsite at all times while children are present.	

Not all CPR or First Aid courses will meet the requirements for licensed child care facilities. The Resource Connection offers Child Care Courses to participants that are currently working in licensed or license exempt child care settings. These courses meet the State of California Child Care Licensing requirements (Health and Safety Code Sections 1596.866 and 1797.113).

Refunds will not be offered for no-shows. Registration is on a first come-first serve basis, based on receipt of registration and fees. In the event that registration fees are received after a course becomes full, the registration fees will be mailed back to the registrant. Please carefully read and choose the appropriate course or combination of courses that will meet your needs.
